Dr Carsten Michael Walbiner DAAD Regional Office Cairo

Carsten Walbiner holds a PhD in Oriental Studies from Leipzig University. Through long years of working at DAAD headquarters and other institutions in Germany, Lebanon, and Palestine, he has gained great experience in the field of academic cooperation between European and Arab partners. During the last five years, he directed, on behalf of the DAAD the HOPES(-LEB) project, an EU-funded initiative aimed/aims at improving the situation of refugees of post-secondary age from Syria and young people in the host communities affected by the high influx of Syrian refugees, by addressing their higher education needs.

He studied pharmacy at Misr University of Science & Technology and graduated in 2003. In 2004, he was recruited for a position as a researcher pharmacist at the NCRRT, where he completed his Master's thesis and then, subsequently, his PhD work. He received his PhD in pharmaceutical chemistry from Cairo University in 2010.

In 2012, he was selected for a Humboldt Postdoctoral Fellowship and started to implement his collaborative research project at the Institute of Pharmacy and Food Chemistry - University of Würzburg. Since January 2022, he has been appointed by the Alexander von Humboldt Foundation as its Ambassador Scientist in Egypt. In 2023, he was also elected Secretary General of the Humboldt Alumni Association in Egypt.

Prof. Dr Michael Bacher Philipps-Universität Marburg

He received his PhD at the Department of Anatomy and Cell Biology at the University of Marburg. He then moved for 4 years to New York to work as a postdoc/Senior scientist at the Pi Cower Institute for Medical Research. He then moved back to the University of Marburg to work as a group leader at the Institute of Immunology. He had a short stint at a pharmaceutical company as an IP manager and moved from there to work as a lab head at the Neurology Department at the University of Bonn. He became a professor in 2008 at the University of Marburg and works again at the Institute of Immunology. He is also the director of the TransMIT Project Division for Innate and Adaptive Immunity.





Prof. Dr Susanne Hartmann Freie Universität Berlin

Prof. Dr Susanne Hartmann is a Professor of Infection Immunology and Director of the Institute of Immunology in the Center of Infection Medicine at the Faculty of veterinary medicine at Freie Universität Berlin. Prof. Hartmann studied biology at the Universities of Tübingen and Oxford (UK) and did her PhD at the Institute of Parasitology at the University of Stuttgart-Hohenheim. She was an assistant professor and group leader at the Humboldt University of Berlin and has been head of the Institute of Immunology at Freie Universität Berlin since 2011. Her research focuses on infections with parasitic worms in humans and animals. She demonstrated immunomodulatory processes and identified the responsible proteins of the parasites. Further, she investigated potential regulatory parasite products for the treatment of inflammatory diseases and worked on the interactions of intestinal worms with the gut microbiota.



Dr Franz Krause University of Cologne

Franz Krause works at the Department of Anthropology and the Global South Studies Center at the University of Cologne, Germany. His research and teaching revolve around the role of water in social and cultural life. Dr Krause has conducted research in the Philippines, Northern Finland, Western England, Estonia, and Arctic Canada. From 2016 to 2023, he has run a research project on everyday life in river deltas around the world. Among his recent publications are Delta Life: Exploring Dynamic Environments Where Rivers Meet the Sea (2021, Berghain, co-edited with Mark Harris) and Thinking Like A River: An Anthropology of Water and Its Uses Along the Kemi River, Northern Finland (2023, transcript).
